Samsung 10 Year Screen Burn Warranty Terms and Conditions

WARRANTY PERIOD

The warranty period in respect of the 10 Year Screen Burn Warranty starts on the date of invoice as shown on the purchase receipt. All of the terms set in these Terms and Conditions shall apply to the 10 Year Screen Burn Warranty. The method of service and operating conditions will be as described in the original warranty statement provided with the Samsung Product. The standard warranty terms and conditions (as set out in the warranty card provided with your product) will not be affected by this promotion, and in the event that you wish to claim in respect of any other issues or defects with your product (other than screen burn), please follow the process set out in your warranty card.

10 YEAR SCREEN BURN WARRANTY CONDITIONS

1. Online registration redemption is necessary in order to benefit from the 10 Year Screen Burn Warranty. Register your product and personal details (name and address) online via www.samsung.com/uk/screen-burn. A valid serial number and an electronic copy/image of your receipt or invoice (showing purchase from one of the retailers listed below) **must** be registered by you as proof of purchase within 90 days of purchase. No warranty repair service will be provided without this registration.

2. The 10 Year Screen Burn Warranty is not transferable to a third party and no alternative will be offered.

3. The 10 Year Screen Burn Warranty applies **only** in respect of screen burn on your TV (i.e. when an image has become "burnt-on" to your screen, no matter what content you are watching). Your standard warranty period for other parts is not affected.

4. The warranty covers qualifying products used in a normal domestic environment <u>only</u> for unintentional or accidental screen burn. Commercial use in <u>any</u> application would invalidate the warranty.

Commercial use examples may include but are not limited to:

- Any commercial use for profit or financial gain, public display or events such as clubs, bars and restaurants including continuous statistical or graphical display.
- Any commercial use of continuous or intentional long term display of News reels ("tickers"), static or fixed images such as timetables and 4:3 pictures or video content displaying permanent black bars.

Samsung is not responsible for paying any travel or delivery costs where the product is located outside the UK or Ireland.

2. Services performed by Samsung in rectifying damage or defect caused as a result of any excluded conditions shall be subject to additional charges for labour, transportation and parts. The 10 Year Screen Burn Warranty is not available to you if the product you present for exchange:

• Has been used for any purpose other than normal domestic use (i.e. any commercial use of the product as described in paragraph 4 of the "10 Year Screen Burn Warranty Conditions" above)

• Is defaced, altered, damaged beyond repair, in need of a repair not included in warranty service.

To the maximum extent permitted by law, warranty service does not include repair of failures caused by:

• Modification or attachments

• Accidents or misuse (to include without limitation failure to following instructions in the user manual)

- Unsuitable physical or operating environment
